Call to order:

This Public Hearing was called to order at 9:00 A.M. by Vilas County Board Chair Stephen Favorite, in the presence of the Vilas County Board of Supervisors and the Redistricting Committee.

Proof of Publication of Public Hearing Notice:

The Chair instructed the clerk to read aloud the following Public Notice:

NOTICE IS HEREBY GIVEN, that the Vilas County Redistricting Committee will hold a public hearing on the final redistricting plan for Vilas County, Wisconsin, pursuant to Section 59.10 of the Wisconsin Statutes.

Presentation of 2011 Final Redistricting Plan:

The Chair presented the 2011 Final Redistricting Plan. (attached)

Public Comment:

The Chair opened the period for public comment. He asked the Vilas County Board members in attendance to refrain from discussion and debate regarding the final redistricting plan, until such time as resolution 2011-71 Adoption of a Final Vilas County Board of Supervisors Redistricting Plan could be properly brought forth during the Vilas County Board meeting scheduled to immediately follow the public hearing. The Chair also requested that members of the public identify themselves and their municipality of residence prior to making any public comment. County Supervisor Dennis Nielsen requested to be heard. He is objecting to the location of the County Supervisory District boundary between districts #1 and #4 as that boundary bisects Sayner, Wisconsin. Mr.

Nielsen's objection was noted and will be considered during deliberation of the Final Redistricting Plan resolution. The Chair made two additional calls for public comment.
