Convene Recount:

Vilas County Clerk David R. Alleman arrived at the recount room at 8:55 A.M. in custody of all ballots to be recounted. He convened the State of Wisconsin Supreme Court Recount at 9:00 A.M. First order of business was the introduction of the Vilas County Board of Canvassers, the tabulators and the Deputy County Clerk. The tabulators were publically administered the Official Oath (EB-154). The Board of Canvassers were also publically administered the Official Oath (reaffirmation). The County Clerk then described the procedures to be followed during the recount. He closed his remarks by addressing both parties present, regarding how they were to conduct themselves during the recount proceedings. The recount then began.

Winchester ballot bag seal #0162569 removed by clerk. Optical scan ballots fed. Results indicated one less OS vote cast for Kloppenburg and two less OS votes cast for Prosser. Included in the Winchester ballot bag were five original absentee ballots clipped together, with a note from the municipal clerk indicating that these five original absentee ballots were remade after April 5th by order of the GAB, as part of a recount conducted by Winchester to determine the outcome of the office of Town Chair. These five original absentee ballots were not fed through the OS machine as part of this recount. The clerk identified five OS ballots that had not been initialed by the municipal clerk or by any other election official. The only votes cast on these ballots were for the office of Winchester Town Chair and those votes matched votes cast for the Winchester Town Chair on the five original absentee ballots. The clerk examined the five original absentee ballots and reported that three of these original ballots showed votes cast for candidates in the State Supreme Court race. One vote was cast for Kloppenburg and two votes were cast for Prosser. The Board of Canvassers unanimously determined that voter intent was obvious and that these votes needed to be added to each candidate's total, thus increasing the total votes cast for each candidate. Vote totals for each candidate now matched April 5th results. There was no challenge issued by either candidate's rep. TSX ballots were recounted by hand with no changes from April 5th totals.
