

**VILAS COUNTY BOARD PROCEEDINGS
2011**

JANUARY 18,

This meeting of the Vilas County Board of Supervisors was held in the conference rooms located in the Vilas County Courthouse, 330 Court Street, Eagle River, WI.

CALL TO ORDER

Vilas County Board Chairman Charles Rayala, Jr. called the assembly to order at 9:04 A.M. and instructed the Clerk to read aloud and insert into the minutes the following: A public meeting notice was given to the public by posting on the bulletin boards in the hall by the main entrance to the Vilas County Courthouse, Olson Memorial Library and Eagle River City Hall. The Vilas County News-Review; the Rhinelander Daily News; the Lakeland Times; the Ironwood Daily Globe; W.E.R.L. Radio; W.R.J.O. Radio; W.L.S.L Radio and Channel 12 TV and News of the North.net were notified on January 13, 2011 more than twenty-four hours prior to the meeting. The Clerk then requested that all present silence their cell phones and pagers for the duration of the meeting.

A. LAND & WATER CONSERVATION 2010 REPORT

Motion by R. Sitzberger, seconded by D. Nielsen to accept the 2010 Land & Water Conservation Department 2010 report. All voted aye. Carried.

WISCONSIN COUNTY MUTUAL INSURANCE CORP. 2009 POLICY YEAR DIVIDEND

The County Board Chairman reported the receipt of a \$8,986.00 insurance dividend paid by the County's liability insurance carrier.

COMMITTEE REPORTS

C. Mayer spoke about the December 2010 zoning permit report. Zoning permit issuances and fees are running ahead of predictions, indicating a rebound in building activity.
E. Teichmiller presented a statistical report highlighting Commission on Aging services provided.

He also reported that the ADRC Planning Committee, made up of five Counties and three Tribal governments, was preparing a resolution for presentation to the March 2011 County Board. The resolution would approve of the formation of a Vilas County ADRC.

L. Thorpe reported on the Personnel Committee's employee evaluation policy.

S. Favorite reported on the status of Forestry Dept. administered tax deed properties. He also reported that 266 acres of county forest were replanted with trees in 2010. He further reported that the Forestry Dept. would close the 2010 financial year with a \$65,000.00 budget surplus. He then stated the Wayne Oldenburg contributed an additional \$10,000.00 towards development of the County's Oldenburg Sports Park.

B. Egan introduced Bill Lochte, Vice-Chairman of the Vilas County Economic Development Corporation (VCEDC). B. Lochte presented an oral and written report covering 2010 VCEDC activities.

M. Platner asked that UW Extension Agent Kelly Haverkamp be recognized for all of her efforts expended in the successful formation of the VCEDC.

K. Rushlow, reporting for the Finance & Budget Committee, reminded Supervisors and staff that the IRS based mileage reimbursement rate recently increased to .51 cents.

LETTERS AND COMMUNICATIONS

The Chairman presented a letter from the Walter Olsen Memorial Library, thanking the County for their continuing financial support to area libraries.

R. Sitzberger expressed his opinion that the Committee reports presented at today's County Board were very beneficial and informative.

S. Hjemvick commented on the number of late resolutions on today's agenda. He feels that the acceptance of late resolutions adversely reduces the time that Supervisors have to consider and investigate issues presented in those resolutions.

Motion by R. Sitzberger, seconded by A. Bauman to approve payment of per diem. All voted aye. Carried.
